7. If at any time the buyer is unable to keep or care for the puppy/dog, it MUST be returned to Jaime Jarosz at Sensational Doodles. The puppy/dog may not be transferred or sold by the buyer. The buyer's understanding and acceptance of this condition is signified here by his or her initials: _____ on _____. The seller will endeavor to place any returned puppy/dog as advantageously as possible. No money will be returned to the original buyer. No veterinary or other costs of keeping the puppy/dog, or any other costs incurred by the buyer resulting from his/her ownership of the puppy/dog, will be paid by the seller to the original buyer of the puppy/dog under any circumstances.

Buyer Agreements

The buyer agrees that if at any time, and for any reason, he/she is unable to keep or properly care for the puppy/dog, it shall be returned to the seller and no one else. The buyer's understanding and acceptance of this condition is signified here by his/her initials: _____ on _____.

1. The buyer agrees to maintain the puppy/dog's health with completed **puppy vaccinations** and **yearly vaccinations** as specified by their veterinarian. _____
2. Should the puppy/dog become ill or unsound, **all costs of treatment** will be the responsibility of the buyer. _____
3. The buyer agrees to keep the puppy/dog in an **appropriate weight** to maximize the puppy/dog's soundness and longevity. _____
4. The buyer agrees to feed only a **well-balanced premium dog food**, that meets the nutritional requirements of the puppy/dog. The buyer understands that dry kibble from a premium and reputable dog food company is nutritionally balanced for the health and well being of the puppy/dog. Foods that are not to be fed include Grain Free, Raw or solely Home Cooked meals as these DO NOT provide all of the nutritional requirements of the puppy/dog. The only exception to this is if it is prescribed by a licensed veterinarian. _____
5. The buyer agrees to **socialize, train**, and keep the puppy/dog in a manner acceptable to the seller. _____
6. If at any time, the seller finds that the puppy/dog is being kept, treated, or allowed to behave in a manner **not acceptable** to him/her, the buyer agrees to surrender the puppy/dog to the seller. It shall include ownership transfer adequately signed. _____
7. The buyer agrees to allow the seller access to the puppy/dog, and to the premises where it is kept, to evaluate the condition they are in. _____
8. The seller recommends the buyer have **OFA hip certification** (Penn Hip can be done sooner) as soon as possible after the puppy/dog reaches 24 months of age. This will allow owner early

detection of any potential extra requirements or maintenance needs of the dog to insure the healthiest, happiest, and soundest pet possible. _____

9. The buyer understands the seller can NOT guarantee the absence of hip dysplasia, as it is common in larger breeds, however the seller takes every precaution in an attempt to minimize its existence. _____
10. The buyer agrees **not** to sue the seller and to pay any and all court or attorney fees incurred by the seller should any suit be brought against the seller regarding this puppy/dog by any person. The buyer signifies acceptance of this condition by initialing here: _____ on _____.
11. The buyer acknowledges that **special coat care**, conditioning, training, and feeding are necessary to produce a happy, healthy adult dog and this care and training is his/her responsibility. _____
